After January 6, several corporations pledged to review and possibly modify their political giving. Many halted all giving during the review. Some did not resume giving. Many did. In 2021, some contributed to specific members of Congress who voted late January 6 not to certify the election. Some did not contribute to specific members but contributed to PACS or to the House or Senate Republican campaign arms NRCC (National Republican Congressional Committee) and NRSC (National Republican Senatorial Committee).
